Pursuant to A.R.S. § 38-431.02, notice is hereby given to the Trustee of the Arizona School Boards Association Insurance Trust and to the general public that the Arizona School Boards Association Insurance Trust will hold a meeting open to the public on August 21, 2017, beginning at 9:30 a.m. in the Community Room at the First Western Trust Bank, 2425 East Camelback Suite 100, Phoenix, Arizona 85016. As indicated in the following agenda, the Arizona School Boards Association Insurance Trust may vote to go into executive session, which will not be open to the public, to discuss certain matters.

The Trustees may vote to enter executive session pursuant to A.R.S., § 38-431.03 (A)(3) or (A)(4) for discussion or consultation for legal advice with or direction to its attorneys concerning any item on this agenda.

The Trustees may vote to enter executive session A.R.S., § 38-431.03 (A)(2), for discussion or consideration of records exempt by law from public inspection.

One or more of the Trustees may participate telephonically in the meeting.

The Trustees may consider any item in this Agenda in any order and at any time during the meeting.

A. Executive Session pursuant to A.R.S. § 38-431.03 (A)(3) and (4) : The Trustees may convene in executive counsel for the purpose of receiving legal advice from the attorney for the public body and providing direction to the attorney regarding contract negotiations with Kairos Health of Arizona.

**V. Board Study Session**

The Board of Trustees may meet to conduct a study session regarding to conduct strategic planning regarding goal setting for the Board; potential for future partnerships; status of marketplace and potential future items for review. Study Sessions are open to the public.

**VII. Future Agenda Items**


Trustees may request that items be considered by the Board of Trustees at a future meeting and scheduling of future meeting dates.
